Mind you, you are a feminist when you take to the streets to demonstrate as well as when you reple to your uncle casual sexist comment at dinner. Everyone has their own feminist path, we just start from different stories.

Mode of participation

Participation is free. To apply your poster you must fill out the form at the link: <https://www.calimaiacollettivo.it/upload-eng/> attaching the file as required. The deadline to send your application is within hours 23:59 on September 15, 2022.

It is possible to participate individually or in groups, as better specified in the point "Participation in a group".

It is possible to submit more than one poster, provided it meets the specified characteristics listed in this document.

It is possible to submit an already published poster, as long as the author holds all the rights, such as better specified in the point "Author rights".

Requirements of participation

Candidates are allowed to those who, on the date of publication of this competition announcement, is under 36 years old.

Participation in a group

It is possible to participate in a group as long as each component is under the age of 36. Those who participate in a group will have to fill in equally a single form, by electing a representative and listing the names of others components of the "Description of the poster".

Those who participate in a group are allowed to participate even individually, as long as it comes candidate a different poster.

Accepted formats

The poster file will need to be sent in **two different formats** that respect the following features:

1. File for digital reproduction

Vertical format: 50x70 cm

Max size: 10MB

Resolution 150dpi

Accepted extensions: JPG, JPEG, PNG

Color profile: RGB

2. File suitable for printing

Vertical format: 50 x 70 cm

Abundance 3mm

Resolution: 300 dpi

Accepted extensions: PDF

Color profile: CMYK

Different types of files will not be allowed.

Criteria of selection

Candidate projects will be evaluated and selected by an internal jury, made up of the members of Calimaia Collettivo and Fiesolana 2b according to the following selection criteria: consistency with theme, quality and graphic originality, visual translation of the concept and communicative effectiveness.

All participants will be contacted to the email address provided during the application depending on whether they are been selected or not.

The organizers reserve the right to add external professionals to the jury who will be communicated from the channels of the project (see section "Communications and contacts").

Acknowledgments

The selected posters will be exhibited at **La Biblioteca Femminista** in Via Fiesolana 2b in Florence from 30 September to 23 October 2022. An inauguration event will be organized for the exhibition opening.

At the end of the exhibition it will take place, both inside and outside of La Biblioteca Femminista, the **Sagra del Manifesto**, a popular celebration. During the event, various activities both cultural and recreational will be organized, such as round table with focus on the project, games and music. Like any self-respecting festival, refreshments will be available at a modest price. The event will be registered within the OFF billboard of the review **L'Eredità delle Donne 2022**.

The printing of materials and the preparation of the exhibition will be borne by Calimaia Collettivo e Fiesolana 2b.

The projects deemed worthy will also come published on the **Calimaia Collettivo** website <https://www.calimaiacollettivo.it> to collect the various points of view relating to the chosen theme, with the purpose to create debate and networking among the people involved in the project.
